INFORMATION FOR AUTHORS

TYPES OF CONTRIBUTIONS ACCEPTED

1. **Originals**. Original articles that contain empirical research, biographies, reviews, among others.

2. **Reviews.** Critical analysis of national or international scientific events, works published, films or documentaries, and websites related to Conscientiology themes.

3. **Interviews.** Interviews with people of recognized competence who contribute to some Conscientiology subdiscipline in a theoretical, practical and exemplary way. 4. **Self-research.** Reports on personal experiences, pre-ferably narrating parapsychic phenomena, OBEs, retrocognitions and precognitions, among others.

5. **Letters.** Publishing of letters sent to the editor with suggestions and/or evaluations of *Conscientia*'s texts, news about ongoing researches and interesting events.

SUBMISSION OF ARTICLES

1. **Identification Sheet.** It should contain: title of the paper in Portuguese and English; the author's full name, qualifications, address and e-mail; the name of the institution to which the researcher is connected to.

2. **Abstract.** The abstract, limited to a maximum of 150 words, should contain a synopsis of the study, its objectives, methodology, results, discussion and conclusions.

3. **Keyword.** In each paper, a set of 3 to 6 keywords must be indicated in the article's original language.

4. **Structure.** The article should be organized in the following order:

a. **Preliminary argument** / **introduction:** presentation of the research context, purposes, organization of the topics and methodology (strategy, materials and methods).

b. Body of the text.

c. **Conclusive arguments:** the text's conclusion should relate the objective of the research undertaken. Results and discussions already presented throughout the text could also be included.

5. **Citations.** Quotations must be given in quotes and followed by the author's surname, date of publication and page(s). Example: "..." (VIEIRA, 1994, p. 111). Long quotations, with more than 50 words, should be transcribed in a single paragraph, with no quotation marks, 4cm from the left margin, single space and reduced size. For further information on specifications, consult the Brazilian National Standards Organization (ABNT).

6. **References.** The references cited in the text should be arranged in alphabetical order and follow the criteria of the Encyclopedia of Conscientiology. *Et al* should only be used after the name of the main author when there are more than 3 (three), otherwise, all of them must be mentioned. As references, only authors quoted in the paper should be included. Other works may be cited as consulted literature.

7. **Illustrations and Tables.** These should be included when essential for the effective understanding of the text and the data. They must be readily intelligible, developed according to the rules of ABNT, present good quality, and provide caption and details of the source, if applicable. Both illustrations and tables must be numbered with consecutive Arabic numerals. The illustrations should be sent apart, in *.jpg* or *.tif* file, with resolution of at least 300 dpi.

8. **Notation.** The notation B.C.E. is used for dates referring to the period before the Common Era, and C.E. for dates of the Common Era.

CRITERIA FOR PUBLICATION

01. **Editorial Board.** The publication of works in *Conscientia* is subject to the approval of the Editorial Board as indicated in the back of each copy of the journal.

02. **Adaptation.** The authors of articles accepted for publication may be requested to adjust the text to the of publishing and the editorial standards of *Conscientia*.

03. **Standard Format.** The written format of the articles submitted for publication should be in agreement with standard format English.

04. **Neologisms.** Neologisms of Conscientiology must be authenticated by the standards of the International Council of Neologistics (CINEO).

05. **Statement.** The author must send, along with the article, a statement authorizing the publication and signing over the copyrights of that work to *Conscientia*.

06. **Exemplar.** The main author of each article will receive a copy of the journal in which the study was published.

07. **Page Numbering.** All pages, except the title page, must be numbered.

08. **Reproduction**. The reproduction of papers published in the journal is permitted with citation of the source.

09. **Responsibility**. The authors of the texts published assume the responsibility for their content, which does not necessarily represent the view of *Conscientia*, ISIC or CEAEC.

10. **Reprints**. Requests for reprints should be made in advance to the responsible authorities. In this case, the person will receive 1 copy in which the paper was published. 11. **Emphatic sentence.** The use of emphatic sentences must be formatted in up to 4 lines, *Arial* typeface, size 16.

Submission. The articles may be sent by e-mail in electronic media, preferably in LibreOffice Writer (.odt), MS Word (.doc/.docx) or text (.rtf) format. There should be no formatting such as separation of syllables, hyphen or elimination of single letters at the end of the line. Headings should be bold and centered. *Liberation Serif* or *Times New Roman* typeface must be used in size 12, spacing 1.5, margins of 3cm, up to 5,000 words.
